# "Protecting The Quill"

Our May speaker is the Hon. Diana L. Moreland, Chief Judge of the Twelfth Judicial District of the State of Florida serving DeSoto, Manatee and Sarasota Counties. She will address the response of the Florida Supreme Court and the Florida Bar Association to the public's growing loss of confidence in lawyers. She will discuss the oversight of lawyers now in place in Florida including the grievance process and the role of the Bar Referee.

## About Our Speaker – The Hon. Diana Moreland

Diana L. Moreland is a graduate of the United States Merchant Marine Academy and Stetson University College of Law. She has been a Circuit Judge in the Twelfth Judicial Circuit since January 2005. Prior to her election to the bench, she was a Partner/Shareholder in the law firm of Reinhart & Moreland. Since taking the bench she has been active in judicial education. She has taught at Judicial Colleges Phase I and II, Advanced Judicial Studies, County Judges Conference and Circuit Judges Conference. In 2022 she was appointed by the Supreme Court of Florida to serve as Chair of the Judicial Needs Assessment Committee. In February 2023 she was honored by being unanimously elected by her peers to serve them as Chief Judge of the Twelfth Judicial Circuit commencing 1 July 2023.

#### Amicus Personae – Karimu F. Hill-Harvey

#### Member of the Association of Retired Attorneys of Sarasota

Karimu F. Hill-Harvey's journey from her upbringing in Orange, New Jersey, to her impactful career as a Judge reflects a lifelong commitment to social justice and community empowerment, particularly within African American communities.

Growing up in a culturally diverse environment, Judge Hill-Harvey was keenly aware of the disparities and injustices faced by marginalized groups. This awareness fueled her determination to pursue a career in law, where she could affect positive change and advocate for those who had been marginalized or overlooked by society.

Her academic achievements, including her Bachelor of Arts degree from Seton Hall University and her Juris Doctorate from Seton Hall School of Law, laid the foundation for her legal career. However, Judge Hill-Harvey's commitment to excellence didn't end with her formal education. She continued to hone her skills and expertise, earning an L.LM. Masters in Trial Advocacy from Temple University, Beasley School of Law, further solidifying her position as a formidable legal practitioner.

As a Municipal Court Judge, Judge Hill-Harvey presided over cases in Essex County, more particularly East Orange, Irvington, and Newark, where she demonstrated a steadfast commitment to fairness and justice. LaResca</u>, where she secured a \$3.25 million settlement, solidified her reputation as a formidable advocate for justice.

Even in retirement, Judge Hill-Harvey remains actively engaged in her pursuit of social justice and community development. Her involvement in various organizations and boards underscores her commitment to creating a more equitable and just society for all. She has been acknowledged for various case laws, and publications and has numerous industry membership affiliations such as the American Arbitration Association (AAA), Financial Industry Regulatory Authority (FINRA), New Jersey Bar, Sarasota County Bar Association Council for Diversity, and Inclusion (former Chair), George Edgecomb Bar Association, Fred G. Minnis, Sr. Bar Association and Association of Retired Attorneys of Sarasota. She is a Board member of The Haven Board of Directors, Forty Carrots, Board of Trustees, Masala Giving Circle, ASALH Manasota, NAACP, Multicultural Health Institute Board Member, Delta Sigma Theta Sorority, the LINKS, Inc. and participates in Sarasota Teen Court.

Through her tireless efforts and unwavering dedication, Judge Karimu F. Hill-Harvey has left an indelible mark on the legal profession and the communities she has served, embodying the values of integrity, compassion, and justice. Her legacy serves as an inspiration to future generations of legal professionals and advocates for social change.
