## JANUARY SPEAKER: James A. Prozzi

Topic: "The Supreme Court and Three Pending Decisions That Could Remake the American Workplace"

The Supreme Court has three cases ready for decision during its current Term that could affect the American workplace. These cases involve three different federal laws: the Wage and Hour Law, the National Labor Relations Act, and Title VI of the Civil Rights Act, as well as the Equal Protection Clause of the Constitution.

As Prozzi, a forty-three-year labor lawyer and eleven year (and counting) adjunct law professor, states, the Supreme Court potentially could remake the private sector workplace in answering the following three questions:

- Is a supervisor paid more than \$200,000 per year entitled to another \$100,000 in overtime pay because he was not paid "on a salary basis"?
- Can a union be sued in state court for property damage caused by a strike, or was the union's conduct "arguably protected" under the NLRA and a state court action therefore subject to federal preemption?
- Could a Supreme Court decision finding that affirmative action in higher education is discriminatory mean that corporate diversity efforts are also discriminatory?

#### About Jim Prozzi:

Jim Prozzi is currently an adjunct professor of law at Stetson University College of Law, teaching Employment Law. He spent his entire legal career, from 1977 until 2020, practicing labor and employment law on behalf of management. He started with an experienced sole practitioner in Pittsburgh, and after ten years, joined the Pittsburgh office of Jackson, Lewis, the country's second-largest labor and employment "boutique" firm. During these years of active practice, Jim's labor law work included union negotiations and arbitrations, as well as National Labor Relations Board elections and hearings. His employment law practice during those years included numerous trials (jury and non-jury) as well as a sub-specialty of advice and litigation in the area of Federal Wage and Hour law. He has argued more than 30 cases before the Federal Courts of Appeals.

# Amicus Personae – Stanley A. Bass Member of the Association of Retired Attorneys of Sarasota

Stanley A. Bass was admitted to the New York and Illinois bars. He attended Bronx High School of Science and CCNY, where he served as president of the Modern Jazz Society for 3 ½ years. After taking a class in American Constitutional Law, he decided to pursue a career as a civil rights lawyer. Upon graduation from the University of Chicago Law School, he was admitted to the Illinois bar, and then served as a law clerk to the first African American U.S. District Judge. He then became a sole practitioner, helping to establish the first Federal Defender Program in Chicago. Upon receipt of a Ford Foundation grant to the University of Chicago Law School to establish a Center for Studies in Criminal Justice, he was retained to set up a Civil Legal Aid Service in the Cook County Jail. In addition to helping inmates with ordinary civil issues, Mr. Bass pursued a law reform agenda, challenging practices and procedures in Chicago's criminal justice system, such as imprisonment of indigents unable to pay fines. See Williams v. Illinois, 399 U.S. 235 (1970).

Subsequently, Mr. Bass was invited to join the NAACP Legal Defense Fund in New York City, where he supervised a nationwide litigation program to protect the rights of prisoners, with special emphasis on the rights of pre-trial detainees in decrepit local jails, who are presumed by law to be innocent. These litigations resulted in several more arguments in the U.S. Supreme Court, bringing the total to five.

Later on, upon the establishment of the New York State Commission on Judicial Conduct, Mr. Bass joined its legal team, and conducted it first public hearing of a judicial disciplinary proceeding. The judge charged with misconduct was found guilty and eventually removed from office by the New York Court of Appeals.

During this period, Mr. Bass also served two terms as a public member of the New York State Board for Psychology, which set standards and conducted disciplinary hearings.

In 1984, Mr. Bass was selected by the U.S. Court of Appeals for the Second Circuit to serve as Staff Counsel, with responsibility to conduct confidential settlement conferences in civil matters. After 27 years of service there, Mr. Bass finally retired and moved to Sarasota, Florida, where he joined ARAS.
