February Program:

Regulation and Governance of Artificial Intelligence: Legal Risk Management Toolkit

For many, artificial Intelligence ("AI") "started" with Hollywood's depiction of an omniscient robotic navigator in the 1968 movie 2001: Space Odyssey. Today, AI represents a technological improvement on Internet-enabled online software-driven business processes. Highly trained AI tools can connect the dots using copy-cat text and syntax. This presentation will define AI, explain how AI operates, consider use cases, identify core risks and review scientific, administrative and legislative responses. It will conclude with a possible toolkit for risk management and compliance for productive and prudent uses of AI. It will cover President Biden's Executive Order, the pending European Union AI Act and some local laws.

Amicus Personae – Jim Bennett

Member of the Association of Retired Attorneys of Sarasota

Jim joined us shortly after moving to Venice in 2006 at the urging of a now deceased friend, Larry Spelman. His arrival from New Canaan, CT followed a nearly three-year term as an Executive Presbyter of the Southern New England administrative unit of the Presbyterian Church (USA) covering CT, RI and MA (except for Boston-Worchester). He took the position before the gig economy had a name, acting as an independent contractor with a monthly retainer, moving from being an Elder in his hometown church.

All the while, he acted in a similar capacity as a lawyer for a brother/sister family corporate complex based in Milan, Italy which he had served as counsel since 1986. That adventure followed the takeover of Revlon by Ronald Perelman, where Jim was vice-president and international counsel of the company's Health Care Group, a de-facto pharmaceutical company generating 54% of Revlon's sales, and 85% of its net income. That business was sold, and he was put out on the street. Fortunately, he had passed the Connecticut bar exam in addition to his initial New Jersey bar admission and could develop a pajama practice out of his home.

The family partnership was interested in a newly approved subdivision in New Canaan, and Jim's real estate broker met the brother at a cocktail party and suggested him as an attorney because he was then chairman of the local Planning and Zoning Commission. The partnership complex is now known as the Palladium Group, and in addition to other world-wide developments, has an extensive Texas tax-credit housing construction and management business. Jim is now the Group's chief legal counsel in the U.S., and you can read all about it at <u>www.palladiumusa.com</u>.

A native of Montclair, NJ, Jim went local after public high school there to Princeton University where he received a bachelor's degree in English, and then escaped to Stanford for law school. Racing home after surviving in what he thought would be paradise, he clerked for a year with the New Jersey Supreme Court in Newark, NJ. General practice in Newark for three years did not fit the bill, so he began a long climb through what was then thought by high rollers to be a dumping ground, "international," with an in-house law practice, first with Warner-Lambert, then Allied Chemical, followed by Richardson-Merrill ("Vicks"), and General Electric Latin America Division, until he found Revlon. He circled around and in NYC to do this.

Not wanting to fall asleep in the Next Station to Heaven, Jim landed a spot on the Venice Planning Commission, and then served two terms on the City Council there, acting among other positions as its representative to the Sarasota-Manatee Metropolitan Planning Organization, ending up as chair of that group his last year on Council. Just having moved to Plymouth Harbor in Sarasota, he continues to bike in the morning and swim in the afternoon, Climate Change permitting, and is on the board of WEDU, the Tampa public television outlet. He is a widower with four children and eight grandchildren.
